


Fig. 1. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values




Fig. 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values



Forward current as a function of forward Fig. 3. voltage; typical values





Fig. 5. Diode capacitance as a function of reverse voltage; typical values











Fig. 9. Average forward current as a function of solder point temperature; typical values




