<b>4. Description of change</b> The label of the product series B84142B*R000 will be modified as shown in UPtoDATE. Furthermore the marking on the terminals is going to be dropped.			
<b>5. Effect on the product or for the customer (benefit, quality, specification, lead time)</b> The former marking of B84142B0025R000 showed L1 respectively L1' on the terminals. This sometimes caused problems on customer side. Operators could connect the EMC filter to L1 because of the terminal marking, although it might have been intended to be connected to L3. By dropping the terminal marking and adjusting the label, this misunderstanding cannot happen any more. To be consistent, also the labeling of B84142B0008R000, B84142B0012R000 and B84142B0016R000 will be modified accordingly.
