






Fig. 5. Transient thermal impedance from junction to mounting base as a function of pulse duration

Fig. 7. PCB layout with minimum footprint for thermal resistance from junction to ambient






**Fig. 8. Output characteristics; drain current as a function of drain-source voltage; typical values**

**Fig. 11. Sub-threshold drain current as a function of gate-source voltage**





Fig. 12. Drain-source on-state resistance as a function of drain current; typical values

Fig. 13. Normalized drain-source on-state resistance factor as a function of junction temperature




Fig. 14. Gate-source voltage as a function of gate charge; typical values






Fig. 15. Gate charge waveform definitions








Fig. 19. Package outline LPAK56; Power-SO8 (SOT669)





Fig. 20. Reflow soldering footprint for LPAK56; Power-SO8 (SOT669)
